

**RESPONSE AND STATEMENT OF SUPPORT AND CONCURRENCE OF
THE PETROLEUM ALLIANCE OF OKLAHOMA**

COMES NOW The Petroleum Alliance of Oklahoma ("The Petroleum Alliance") on behalf of its members and hereby submits its Response and Statement of Support and Concurrence for the conclusions and recommendation of the Administrative Law Judge ("ALJ") regarding the applicability of 17 O.S. § 158.25(F) to competitive loads greater than 1,000 kW ("1 MW customers") served prior to November 1, 2023. The Petroleum Alliance supports and concurs with the recommendation of the ALJ that the Commission find and order that the clear language of the statute and the Commission rule adopted to give effect to the new statute, OAC 165:35-11-4, require application of the respective provisions of the statute and rule to new 1 MW customers that have signed contracts for service on or after November 1, 2023, and that all existing load customers, *i.e.*, those customers with signed contracts prior to November 1, 2023, for service with OG&E outside its certified territory are not new load.
