APPLICATION

COMES NOW Oklahoma Gas and Electric Company, hereinafter "Applicant", "OG&E", or "Company", and shows as follows:

I. Parties.

OG&E is an investor-owned electric public utility that owns and operates plant, property, and other assets used for the generation, production, transmission, distribution, and sale of electric power and energy in the states of Oklahoma and Arkansas. OG&E is incorporated in the State of Oklahoma and is subject to the regulatory authority of the Oklahoma Corporation Commission ("Commission") with respect to its retail rates and charges for sales of electricity made within the State of Oklahoma. II. Facts.

- A. Applicant is seeking approval of a mechanism that allows for interim recovery of the costs associated with its Oklahoma Grid Enhancement Plan ("OGE Plan").
- B. The OGE Plan is a 5-year plan which includes strategic, data driven investments covering grid resiliency, grid automation, communication systems, and technology platforms and applications.
- C. Applicant does not seek preapproval of the OGE Plan in this docket but seeks only approval of a mechanism to recover costs directly related to the Plan as portions of the Plan are completed and placed in service and following Commission review and approval.
- D. The proposed mechanism will provide recovery of the revenue requirement of projects that are placed in service. The revenue requirement will include a return on rate base, depreciation, and ad valorem taxes.
- E. All costs included for recovery in the mechanism will be subject to a final prudence review in a future general rate case.
- F. Applicant has calculated the customer impacts as follows:

G. Applicant projects that estimated quantitative and qualitative benefits of the OGE Plan will exceed the cost of the project.

III. Legal Authority.

The Commission has jurisdiction to grant the relief requested herein by virtue of Article IX, Section 18, of the Oklahoma Constitution, 17 O.S. §152 et seq., OAC 165:35, and relevant Oklahoma case law.

IV. Relief Sought.

WHEREFORE, premises considered, Oklahoma Gas and Electric Company respectfully requests that the Oklahoma Corporation Commission issue an Order approving the request for approval of a recovery mechanism to recover costs related to the OGE Plan.
